### Introduction

The Register of Irish Sign Language Interpreters (RISLI), a voluntary, national, professional register.

The registration system is referenced in the <u>2017 Irish Sign Language Act</u> (referred to as an 'accreditation scheme') and the <u>National Disability Inclusion Strategy 2017 – 2021</u>

RISLI is funded and supported by Citizens Information Board and the Department of Social Protection. SLIS provides secretarial support to RISLI and administers the decisions of the Registration Panel.

# **Policies and Procedures**

The purpose of RISLI was amended in the Register Structure and Governance paper, to the following:

- Establish and maintain a standards-based registration system for Irish Sign Language Interpreters to ensure protection primarily for the Deaf community and service providers.
- Set the standards for the provision of Irish Sign Language interpreting that all public bodies require.
- Support public bodies through access to a public register of interpreters.
- Support professional Irish Sign Language interpreters to meet and maintain standards.
- Promote social inclusion of Irish Sign Language users by supporting the use of registered interpreters including access to public bodies.

RISLI continues to develop and review the policies and procedure of RISLI.

Once the policies have been approved by the Registration Panel, they will be updated on www.risli.ie

#### **Registration Panel**

RISLI is governed by a Registration Panel 11 members, who serve in a voluntary capacity to maintain the voluntary professional register.
